- Raise Right: Sign up for www.RaiseRight.com. When you
 purchase gift cards for major retailers, they'll donate a
 percentage to VIBE. (ENROLLMENT CODE: 7UJTNVRQTRVC)
 - Download the app. Send the link to family and friends so they can support VIBE, too! Purchase gift cards for yourself to spend at Stop & Shop, Amazon, Starbucks, etc.
- Volunteer Time Matching: Get your employer to match your VOLUNTEER TIME with a donation through Benevity.org -https://causes.benevity.org/user
- Donation Matching: Find out if your employer has a donation matching program and ask them to match your donations. ASK if they'll match your participation fee as well.
- Directed QCD: For people over age 70.5 who must take a
 Required Minimum Distribution from their IRA each year, making
 a Qualified Charitable Distribution directly to a non-profit like
 VIBE Show Choir Supporters can reduce taxable income and
 help avoid increases in medicare insurance premiums. <u>Tell</u>
 your family about this!
- Donor Advised Fund (DAF): An investment account for
 philanthropic giving that offers an immediate tax benefit and
 the flexibility to support your preferred charities. Provide a onetime donation to help with expenses this season, set up a
 recurring donation to help each season, or name Vibe Show
 Choir Supporters as the beneficiary for your DAF to provide
 support after your lifetime.
